This project has a recreation element which may include building a retention pond along with picnic tables and a playground on 7th St. Mayor Hammond asked the Commission if they had been notified of the groundbreaking at the new City Complex that is tentatively scheduled for October 10th at 12:30 p.m. Mayor Hammond stated Tyndall Air Force Base has already reached out and volunteered to conduct a F-35 flyover.
