I. CALL TO ORDER

Mayor Hammond called this Special Call Commission Meeting to order on this the 12th day of December 2023 at Springfield City Hall. Notice was provided to the News Media via email and on the City's website.

Before continuation of the agenda, Mayor Hammond told the City Commission the latest picture of the City's Gateway Signs was included in the packet. He noted the sign will be outlined in a brick façade (break-away as required by FDOT) to match the brick planned for the new City Hall Complex.

II. REGULAR AGENDA

1. RFP Bid Selection for HMGP Sanitary Sewer Bypass Pumps

Mayor Hammond reported bids were received and opened on December 5, 2023, for the HMGP Sanitary Sewer Bypass Pumps project. He announced the bid amounts as follows:

- Marshall Brothers – \$609,300.00
- J & P Construction – \$730,000.00
- Royal American – \$946,788.00

Mayor Hammond reported all bids had been verified by Tommy Pitts of Mott MacDonald Engineering, the engineering firm for the project. He told the City Commission per the HMGP grant agreement; the bid award must go to the lowest bidder.

Motion by Commissioner Griffis to award the bid to Marshall Brothers Construction in the amount of \$609,300.00. Motion seconded by Commissioner Kennington. Roll Call: All ayes; motion carried (4-0).

Mayor Hammond thanked Mr. Tommy Pitts for his hard work.
