

**CITY OF SPRINGFIELD**

**ORDINANCE NO. 518**

AN ORDINANCE OF THE SPRINGFIELD CITY COMMISSION AUTHORIZING BAY COUNTY TO INCLUDE CERTAIN PARCELS WITHIN A MUNICIPAL SERVICE TAXING OR BENEFIT UNIT ESTABLISHED AND ADMINISTERED BY BAY COUNTY FOR THE PURPOSES OF PAVING SEQUOIA AVENUE; PROVIDING AUTHORIZATION FOR UP TO FIFTEEN YEARS, PROVIDING THAT TERMINATION OF AUTHORIZATION SHALL NOT AFFECT CLAIMS OR LIENS; PROVIDING FOR SEVERABILITY; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, pursuant to Article VIII, Section 2 of the Florida Constitution, and Chapter 166, Florida Statutes, the City of Springfield, Florida (hereinafter "City") has the power and the authority to enact ordinances and regulations for valid governmental purposes that are not inconsistent with general or special law; and

**WHEREAS**, the County is authorized pursuant to section 125.01(1)(q), Florida Statutes, to establish municipal service taxing or benefit units, the boundaries of which may include all or part of the boundaries of a municipality, subject to the municipality's consent by ordinance;

**NOW, THEREFORE, BE IT ENACTED** by the people of the City of Springfield, Florida that:

**SECTION 1. CONSENT.** Pursuant to section 125.01(1)(q), Florida Statutes, the City Commission of the City of Springfield consents and authorizes Bay County to include the following described parcels, identified by parcel numbers and the attached map, within the boundaries of a municipal service taxing or benefit unit established and administered by Bay County for the purpose of paving Sequoia Avenue:

12317-013-000

12317-010-000

SECTION 2. TERM. This consent and authorization is given for a period of up to fifteen (1) years.

SECTION 3. TERMINATION. The termination of this consent and authorization shall not affect any claim or lien created pursuant to the municipal service taxing or benefit unit established by Bay County.


SECTION 4. SEVERABILITY. The provisions of this Ordinance are severable; and if any section, subsection, sentence, clause or provision is held invalid by any court of competent jurisdiction, the remaining provisions of this Ordinance shall not be affected thereby.

SECTION 5. REPEALER. All ordinances, resolution or parts thereof, including but not limited to Chapter 27900, Laws of Florida (1951), as amended (which became a City ordinance pursuant to and upon enactment of Section 166.021(5), Florida Statutes), which are inconsistent or in conflict herewith are hereby repealed and of no further force and effect.


SECTION 6. EFFECTIVE DATE. This Ordinance shall be in force and take effect immediately upon its passage and adoption by the City Commission.

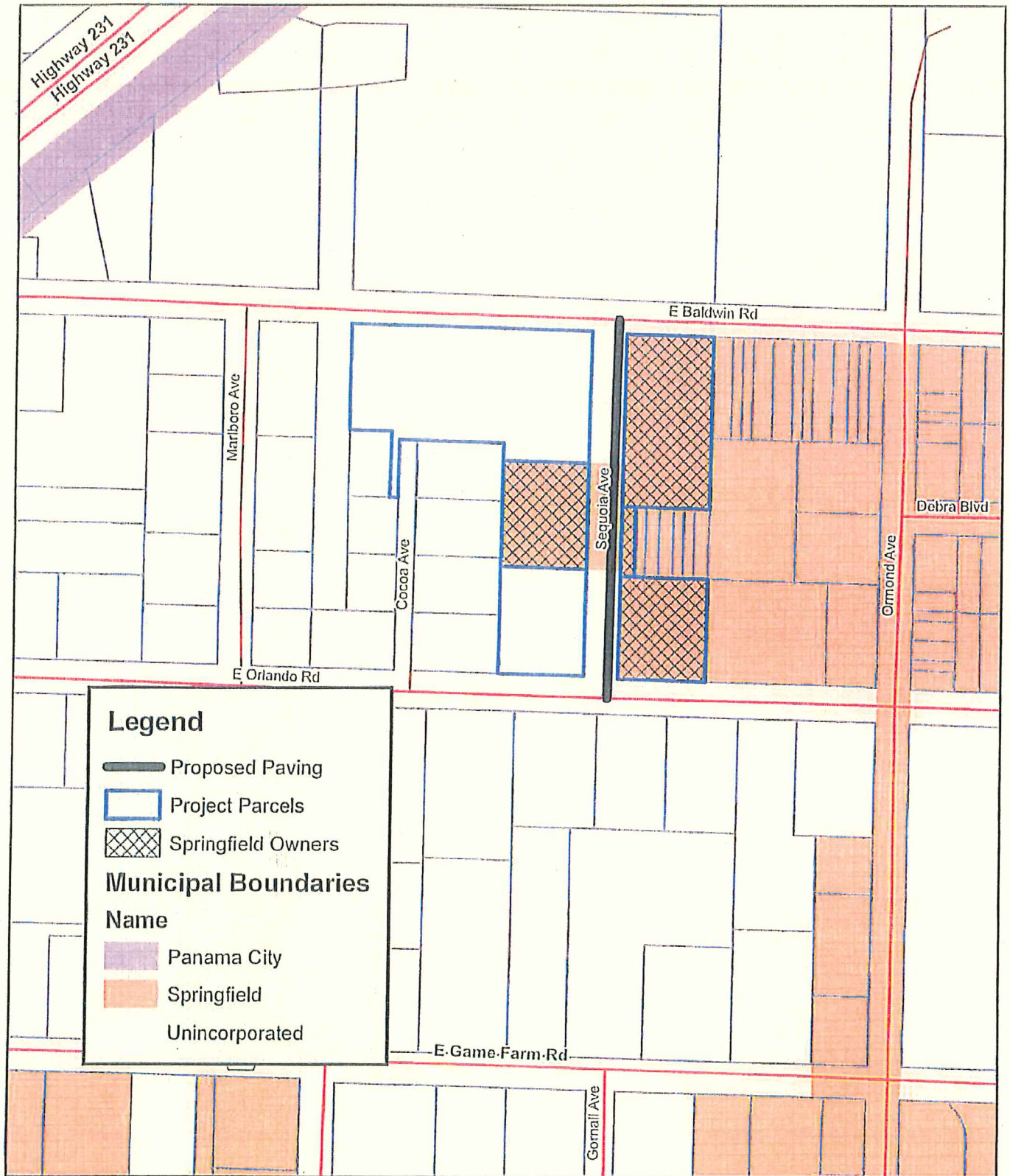
