ORDINANCE NO. 546

AN ORDINANCE ANNEXING THE FOLLOWING UNINCORPORATED AREA OF BAY COUNTY WHICH IS CONTIGUOUS TO THE CITY OF SPRINGFIELD, FLORIDA, UPON PETITION OF THE OWNER OF SAID PROPERTY: 1232 BOB LITTLE ROAD, PARCEL ID 14947-000-000, AS MORE PARTICULARLY DESCRIBED IN THE BODY OF THE ORDINANCE; REDEFINING THE BOUNDARY LINES OF THE CITY; PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY UPON PASSAGE.

WHEREAS, Mary Hopper, owner of real property in an unincorporated area of Bay County which is contiguous to this City, has filed a petition praying that said real property, being more particularly described below, be annexed to this City, and

WHEREAS, the City Commission of this City has determined that the petition bears the signatures of all the owners of the property in the area proposed to be annexed, and

WHEREAS, Notice of Voluntary Annexation for this property has been published in the Panama City News-Herald once a week for two (2) consecutive weeks prior to this date, the same being a newspaper of general circulation in this City.

NOW, THEREFORE, BE IT ENACTED BY THE PEOPLE OF THE CITY OF SPRINGFIELD, FLORIDA:

Section 1. It is hereby annexed and made a part of the City of Springfield, Florida, the following described lands in Bay County, Florida, to-wit:

Section 2. The boundary lines of the City of Springfield, Florida, are redefined to

include therein said tracts of land.

Section 3. A map of the area to be annexed is attached.


Section 4. This ordinance shall take effect immediately upon passage.

THE PUBLIC IS HEREBY NOTIFIED that the owner of the parcel generally described below has petitioned the City of Springfield to annex the parcel into the City. The parcel is unincorporated and contiguous to the municipal limits of the City. The parcel is located at 1232 Bob Little Road. A map showing the area and location of the parcel to be annexed is shown below.

The Ordinance will be considered by the City Commission for final adoption at the regular Commission meeting, Monday, March 4, 2019, at 5:30 p.m. at the Springfield City Hall located at 408 School Avenue.

If a person decides to appeal any decision made by the City Commission with respect to any matter considered at the meeting, if an appeal is available, such person will need a record of the proceeding, and such person may need to ensure that a verbatim record of the proceeding is made, which record includes the testimony and evidence upon which the appeal is to be based.
