A RESOLUTION OF INTENT TO VACATE AND ABANDON
AN ALLEYWAY SITUATED BETWEEN CHERRY STREET
AND 1ST COURT AND EVERITT AVENUE AND POSTON
AVENUE IN THE CITY OF SPRINGFIELD, AS MORE
PARTICULARLY DESCRIBED HEREINAFTER.

WHEREAS, requests have been made upon the City Commission of the City of Springfield, Florida, to vacate and abandon an alleyway situated between Cherry Street and 1st Court and Everitt Avenue and Poston Avenue in Springfield, Florida, as more particularly hereinafter described, and

WHEREAS, it appearing unto the Commissioners that the vacation of the aforesaid alleyway would not interrupt any future plans or needs of the City or otherwise be in derogation of public rights;

NOW, THEREFORE, BE IT RESOLVED that the City of Springfield, Florida, does hereby declare its intent to vacate and abandon the alleyway between Cherry Street and 1st Court and Everitt Avenue and Poston Avenue, more particularly described as follows:

Commence at the Southwest corner of Lot 15, Block 2 of North Mooretown, as per plat recorded in Plat Book 6, Page 35 of the Public Records on file with the Clerk of the Circuit Court of Bay County, Florida. Thence, North 250 feet to the South Right-of-way line of 1st Court, thence West 20 feet, thence South 250 feet to the north Right-of-way line of Cherry Street, thence East 20 feet to the Point of Beginning.

BE IT FURTHER RESOLVED that the City Clerk be and he is hereby directed to give notice of the intent of the City to vacate and abandon the described alleyway as herein defined, by publication of this Resolution in a newspaper of general circulation in Bay County, Florida, requesting all persons having an interest in or desiring to be heard on the subject to appear at a meeting of the


City Commissioners on the 17th day of May, 1993, at 6:30 p.m. at the City Hall, Springfield, at which time the following entitled ordinance effectuating the above vacation will be presented for final adoption.

AN ORDINANCE VACATING AND ABANDONING THAT ALLEYWAY SITUATED BETWEEN CHERRY STREET AND 1ST COURT AND EVERITT AVENUE AND POSTON AVENUE IN SPRINGFIELD, FLORIDA, AS MORE PARTICULARLY HEREINAFTER DESCRIBED; REPEALING ALL ORDINANCES IN CONFLICT HERewith AND RECITING AN EFFECTIVE DATE.

BE IT FURTHER RESOLVED that the City Clerk be and he is hereby directed to mail a copy of this Resolution to all owners of property abutting the aforesaid right-of-way or who may otherwise be affected by the vacation thereof, at their last known addresses as shown on the tax rolls.
