**RESOLUTION NO.: 07-11**

**A RESOLUTION OF THE CITY OF SPRINGFIELD, FLORIDA,  
IN BAY COUNTY, FLORIDA ESTABLISHING WATER  
SERVICE RATES AND ADJUSTING BASE RATES FOR THE  
FISCAL YEAR 2007-2008 AND THEREAFTER; REPEALING  
ALL RESOLUTIONS OR PARTS THEREOF WHICH ARE IN  
CONFLICT HERewith; AND PROVIDING FOR AN  
EFFECTIVE DATE.**

**BE IT RESOLVED BY THE SPRINGFIELD CITY COMMISSION THAT:**

**SECTION 1. WATER RATES.**

Those rates for water service to residential, commercial, and industrial required by Sections 82-37 and 82-64 of the Code of Ordinances of the City of Springfield shall be as follows:

- A. The monthly base charge, independent of water volume consumed, shall be \$6.92.
- B. That consumption charge called for in Section 82-67 shall be based on the metered volume of water and shall be charged \$2.82 per one thousand gallons or any portion thereof.
- C. The monthly bill for water service called for by Section 82-67 of the Code of Ordinances shall be the sum of the base charge and the consumption charge applied to all metered water.

**SECTION 2. AUTHORIZATION AND REPEALER.**

This Resolution is adopted pursuant to Sections 82-37, 82-67, 82-241 and 82-247 of the Code of Ordinances of the City of Springfield authorizing the amendment of charges and fees by resolution by the City Commission. Those portions of Sections 82-37, 82-67, 82-241 and 82-247 contained in this Resolution which do not specify charges and fees are neither modified nor re-adopted by this Resolution and are included herein for convenient reference only. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION 3. CODIFICATION.**


The appropriate officers and agents of the City are authorized and directed to codify, include and publish the provisions of this Resolution with the City of Springfield Code. Section numbers may be assigned and changed whenever necessary or convenient.

**SECTION 4. EFFECTIVE DATE.**


This resolution shall take effect as to allow the increase to be collected on the utility bills due in October, 2007.
