**WHEREAS**, pursuant to the City Charter and Ordinances of the City of Springfield as the same pertain to elections and applicable Florida Statutes, a regular municipal election was scheduled to be held on Tuesday, April 21, 2009, for the purpose of filling a mayoral seat and two (2) City Commission seats for two (2) year terms; and

**WHEREAS**, incumbent City Commissioner Jimmy Talley qualified for re-election and was the only candidate to qualify for Commission Seat Ward No. 3 (three); and


**WHEREAS**, incumbent City Commissioner John Gipson qualified for re-election and was the only candidate to qualify for Commission Seat Ward No. 4 (four); and

**WHEREAS**, applicable State Law provides that...when there is only one candidate of any political party qualified for an office, the name of the candidate shall not be printed on the primary election ballot, and such candidate shall be declared nominated for the office.


**NOW, THEREFORE BE IT RESOLVED** by the City Commission of the City of Springfield that Jimmy Talley being unopposed for Commissioner Seat Ward No. 3 (three) and John Gipson being unopposed for Commissioner Seat Ward No. 4 (four) is hereby declared elected as City Commissioners of the City of Springfield for a two (2) year term commencing with the administering of the Oath of Office and acceptance thereof by the candidate.
