RESOLUTION NO.: 10-06**

WHEREAS, pursuant to the City Charter and Ordinances of the City of Springfield as the same pertain to elections and applicable Florida Statutes, a regular municipal election was scheduled to be held on Tuesday, April 20, 2010, for the purpose of filling two (2) City Commission seats for two (2) year terms; and

WHEREAS, incumbent City Commissioner Carl Curti qualified for re-election and was the only candidate to qualify for Commission Seat Ward No. 1 (one); and

WHEREAS, incumbent City Commissioner Ralph Hammond qualified for re-election and was the only candidate to qualify for Commission Seat Ward No. 2 (two); and

WHEREAS, applicable State Law provides that..."when there is only one candidate of any political party qualified for an office, the name of the candidate shall not be printed on the primary election ballot, and such candidate shall be declared nominated for the office.

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of Springfield that Carl Curti being unopposed for Commissioner Seat Ward No. 1 (one) and Ralph Hammond being unopposed for Commissioner Seat Ward No. 2 (two) is hereby declared elected as City Commissioners of the City of Springfield for a two (2) year term commencing with the administering of the Oath of Office and acceptance thereof by the candidate.
