
WHEREAS, incumbent City Commissioner John Gipson qualified for re-election and was the only candidate to qualify for Commission Seat Ward No. 4 (four); and

NOW, THEREFORE BE IT RESOLVED by the City Commission of the City of Springfield that John Gipson being unopposed for Commissioner Seat Ward No. 4 (four) is hereby declared elected as City Commissioner of the City of Springfield for a two (2) year term commencing with the administering of the Oath of Office and acceptance thereof by the candidate.




