A RESOLUTION ADOPTING THE FINAL BUDGET OF THE CITY OF SPRINGFIELD, BAY COUNTY, FLORIDA, FOR THE FISCAL YEAR 2015 – 2016; AND PROVIDING AN EFFECTIVE DATE.

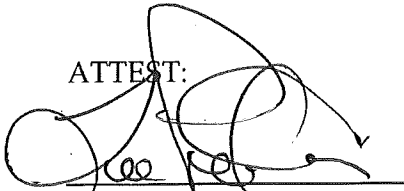
This Resolution shall be in force and take effect immediately upon its passage and adoption by the City Commission.
