RESOLUTION NO.: 16-01

A RESOLUTION OF THE CITY OF SPRINGFIELD, FLORIDA, AMENDING RESOLUTION 14-04 TO AMEND THE COMPENSATION OF THE MAYOR-COMMISSIONER; REPEALING ALL RESOLUTIONS OR PARTS THEREOF WHICH ARE IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Charter of the City of Springfield provides that the Mayor-Commissioner and each Commissioner are entitled to receive such compensation as may be prescribed from time to time by Resolution of the City Commission; and

WHEREAS, the City Commission prescribed various compensation amounts through the years through both Ordinance and Resolution; and

WHEREAS, in 2014, due to the financial condition of the City, the City Commission deemed a decrease in Mayor-Commissioner and Commissioner compensation to be in the best interest of the City and adopted such decrease in Resolution 14-04; and

WHEREAS, the City is governed as a Mayor – Commissioner type of government wherein the Mayor’s duties include supervision of all department heads; and

WHEREAS, in recognition of the extensive duties and hours required to fill the role of Mayor in the City, the City Commission determines that the Mayor’s compensation shall be increased for the remainder of the current budget year and reviewed annually each September prior to adoption of the next fiscal year budget;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SPRINGFIELD, FLORIDA:

SECTION 1. MAYOR COMPENSATION.

- A. The Mayor-Commissioner shall be entitled to receive compensation in the amount of \$1,200.00 per month for each month he or she serves as Mayor-Commissioner, payable on or before the 15th day of each and every month for the preceding month of service.
- B. Each September, prior to the adoption of the next fiscal year budget, the City Commission shall set by Resolution the compensation amount for the Mayor-Commissioner for the upcoming fiscal year. Failure to adopt a Resolution prior to the next fiscal year shall result in the Mayor-Commissioner compensation amount reverting to \$600.00 per month as currently set forth in Resolution 14-04.

SECTION 2. AUTHORIZATION AND REPEALER.

This Resolution is adopted pursuant to Section 11 of the City Charter, Ordinance 359 of the City of Springfield authorizing the amendment of elected official compensation by resolution by the City Commission, and Section 112.08, Florida Statutes, authorizing the City Commission to determine the portion of group insurance costs to be paid by the City. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 3. EFFECTIVE DATE.

This resolution shall take effect immediately upon passage.
