FLORIDA ACCEPTING THE RESULTS OF THE SUPER  
TUESDAY ELECTION IN THE CITY OF SPRINGFIELD,  
FLORIDA.**

**WHEREAS**, pursuant to the City's Charter and Ordinance No. 527 of the City of Springfield as the same pertain to elections and applicable Florida Statutes, a regular municipal election was scheduled on Tuesday, April 21<sup>st</sup>, 2020 also known as Super Tuesday for the purpose of filling two (2) City Commission seats for four (4) year terms; and

**WHEREAS**, incumbent City Commissioner Phillip Dykes qualified for re-election and was the only candidate to qualify for Commission Seat Ward No. 2 (two); and


**WHEREAS**, Dennis Haddock qualified for election and was the only candidate to qualify for Commission Seat Ward No. 1 (one); and

**WHEREAS**, applicable State Law provides that when there is only one candidate of any political party qualified for an office, the name of the candidate shall not be printed on the primary election ballot and such candidate shall be declared nominated for the office.

**NOW, THEREFORE, BE IT RESOLVED** the City Commission of the City of Springfield hereby accepts Phillip Dykes being unopposed for Commission Seat Ward No. 2 (two) and Dennis Haddock being unopposed for Commission Seat Ward No. 1 (one) and declares both to be elected as City Commissioners of the City of Springfield for a four (4) year term commencing with the administering of the Oath of Office as attached hereto and acceptance thereof by each candidate.






